Last Thursday, Christian Ziegler, Head of Sustainability, Environment and Energy, Christian Wurster, Head of Operative Excellence and fischer ProcessSystem and Maximilian Bronner, Managing Director at the fischer Group of Companies, accepted the award in Leipzig. "The Lean & Green Management Award and our benchmarking against other top companies are an ideal opportunity for us to regularly and
